Jack lived most of his adult life in the Harleysville, PA area, and was known as a hard-working community-minded business owner as proprietor of the popular Jack's Village Restaurant. He coached his children's soccer and baseball teams and volunteered with Harleysville Fire Company. Jack is a Charter Life Member of Harleysville Fire Company and was instrumental in the formation of the Harleysville Community Ambulance where he served as President. After he closed the restaurant, Jack followed his passion for patient care, studied to become a paramedic and enjoyed 25 years in his second career in medical transportation.

Jack retired in 2017 when Christy's work took them to Seattle, WA. They lived on Bainbridge Island for 4 years where Jack took up target shooting, organic farming and raising chickens. Jack volunteered with Bainbridge Island Fire Department, teaching community first aid and CPR classes. He also helped educate Island residents on disaster preparedness in partnership with Bainbridge Prepares. As a result of his work, he was elected by the residents of the City of Bainbridge Island to Fire Commissioner in 2019 where he served until 2021, when he and Christy followed their dream and moved to Florida.

He received a bachelor's degree from St. Leo University in St. Leo, FL in 1975 and remained close with his Sigma Beta brothers for over 50 years, faithfully traveling to annual reunions in Englewood, FL and a big part of why Florida was his final destination. Always a community servant, Jack volunteered on various committees with the Rotonda West Homeowners' Association in Florida and was elected to the Rotonda West Association Board of Directors in 2022 where he proudly served until his passing. His family always came first, and his friendships were a close second, many from Olney, which he cherished deeply.

There are not enough words to express Jack and Christy's heartfelt thanks for the steadfast support of family and friends during these difficult months. Jack and Christy were fortunate to have support throughout Jack's journey, however, many suffering with cancer are unable to work to afford basic living expenses in addition to the cost of cancer treatment. In Jack's memory and in lieu of flowers, we ask that you donate to the Florida Cancer Specialists Foundation which helps cancer patients with non-medical household expenses.

A celebration of life will be held at a later date in the fall, details will be shared on Facebook.

RWA COMMITTEES AT WORK

THE RESIDENTIAL MODIFICATION COMMITTEE

The Residential Modification Committee is the sixth standing committee of the Rotonda West Association presented in our series, *RWA Committees at Work*.

To understand what makes Rotonda West a Deed Restricted Community, the roles of three committees need to be understood, along with our role as residents.

The following three committees, namely the Deed Restriction Committee, the Residential Modification Committee (RES MOD as it is often referred to), and the Compliance Committee work together to uphold the HOA rules that make Rotonda West a deed restricted community helping to protect property values.

- Deed Restriction Committee: advises and assists the Board of Directors in carrying out its responsibility for enforcement of the Association's deed restrictions, such as reviewing the State Legislature's Session to keep up to date on any changes adopted to the statutes and policies which govern homeowner's associations. Also, to make any recommendations, as appropriate to the Board for revisions in the Association's deed restrictions.
- Residential Modification Committee: reviews and approves additions or modifications to existing resident's homes or structures under a set of guidelines. Examples of changes may include: putting up fences, adding boat docks, repainting the home, or adding a new roof to name a few. A Residential Modification Application (RMA) is needed for these changes. This committee is established by Deed Restriction Committee.
- Compliance Committee: a mandated committee under Florida State Statute. This committee provides a review process for potential violations of the deed restriction rules.

The Residential Modification Committee is made up of volunteers who are neighbors, and who perform an important job which help keep Rotonda West a beautiful place to live, and help to keep our property values high.

CANDIDATES NEEDED FOR NEXT ELECTION CYCLE

Do you have the desire to serve your community? Then now is the time for you to step up and become a candidate for the Rotonda West Board of Directors. Two Board seats are up for election in 2024 and Directors elected this year will serve a three-year term commencing in December of 2024 and continuing through December 2nd, 2027.

Interested, but you need some more information? We've got you covered. If you want to know more about the election process in general or what you must do to become a candidate specifically, log on to the Rotonda West website at rotondawest.org, choose "Governance" from the top menu and then select "RWA Elections". Once you're on that page you will see two documents you can read and download. The first is the *2024 Election Committee Rules, Procedures and Political Campaign Guidelines* which provides information on the whole election process. The second document is the *2024 Board of Directors Candidate Packet*, and that document provides specifics on how to declare your candidacy for a Director position.

Once you've read the documents and made your decision to become a candidate, there are several action items and dates to remember:

 **Candidate Workshop-July 10, 2024**— The election committee held a candidate workshop on Friday July 10th to inform prospective candidates of what they must do to become a qualified board candidate. This workshop was able to be viewed on zoom. The workshop is available online at [Election Committee on Vimeo](#).

Submittal Deadline for Candidate Documents - Friday, August 9, 2024 - All candidate documents must be deposited in the candidate information lockbox located at the RWA Office at 646 Rotonda Circle no later than 12:01 p.m. on Friday, August 9, 2024. These documents can be submitted by either the candidate or their proxy.

Election Committee Meeting to Review and Certify Candidate's Documents - Friday, August 9, 2024 - The election committee will review all submitted candidate documents at its meeting beginning at 1:00 p.m. on Friday, August 9, 2024, and finalize its recommendation to the Board regarding which candidates should be qualified/disqualified. Candidates are invited to this meeting where they will have the opportunity to correct any issues with their documents.

On July 10th the Community Outreach Committee presented a “Hands On” CPR & AED training class for residents. This event offered life-saving information on what to do if someone collapses. It also gave the audience an opportunity to try out the techniques on mannequins while supervised by two members of the Englewood Emergency Response Team.

Before the “hands-on” segment, presenters Fire Marshall Kyle Books, and Lieutenant and paramedic Joshua Jacobs explained the first steps to take if you see someone is down. It is vital to quickly assess the situation and then take steps to help.

- Start with a “look, listen, and feel” approach
- Ask the person, “Are you ok?”
- If no answer, firmly rub your knuckles on their sternum
- If no response, check for a pulse
- Count to ten while checking pulse
- Start CPR (to the beat of “Stayin Alive” by the Bee Gees)
- If people are with you, point to someone and say “Call 911”
- If there is an AED available, point to someone to get it
- Follow the directions the AED will give you
- If there is not AED available, continue CPR until someone can relieve you.
- If you are alone, call 911 first, then begin CPR

In addition, the presenters reviewed what to do if someone is choking, or if you are choking and by yourself. Both scenarios require what is now called the “Abdominal Thrust”. The term “Heimlich Maneuver” is no longer used.

On Wednesday, July 10th the Rotonda West Homeowners Association along with the GFWC Rotonda West Woman's Club hosted a Charlotte County Candidates event for residents of Rotonda West and surrounding areas. An impressive slate of candidates were in attendance both sitting at the main table and in the audience. The event was well-attended with a live audience of 80 people and another 20 attending on zoom.

Gwen Grace, president of the Woman's Club, and Sam Besase, RWA Board of Directors member and its treasurer, were the hosts for the evening's event. Ms. Grace introduced the candidates and explained the rules regarding the length of their respective speaking time. The candidates then had an allotted time to give information on their backgrounds, education, and work experience. They also presented their positions on important issues that affect Charlotte County residents.

Following the presentations, a question & answer segment for the candidates was run by Sam Besase. These written questions were submitted earlier in the evening by the attending audience. The questions asked of the candidates were relevant and varied, from inquiring about moratoriums on car washes & storage units, to water & sewer capacity for the future, to budget issues in the Sheriff's department, to supervision of elections. The evening wrapped up with closing statements by the candidates, followed by an opportunity to speak to the candidates after the event.

This forum offered a chance to become a better informed voter, and to get a better understanding of how our local government works.

COMMUNITY EMERGENCY RESPONSE TEAM (CERT) OF CHARLOTTE COUNTY

The Charlotte County Community Emergency Response Team (CERT) Program educates people about disaster preparedness for hazards that may impact their area. CERT members learn to assist others in their neighborhood or workplace following an event when professional responders are not immediately available to help. CERT members also are encouraged to support emergency response agencies by taking a more active role in emergency preparedness projects in their community.



The CERT program is a hands on all-risk, all-hazard training. This valuable 3-day course is designed to help you protect yourself, your family, your neighbors and your neighborhood in an emergency situation.

CERT training consists of the following classes:

- **Disaster preparedness:** Instructs team members how to prepare themselves and their community for the various types of hazards that may occur.
- **Team organization and disaster psychology:** Learn to work well in a team setting under stressful emergency event.
- **Fire safety:** Covers proper techniques for preventing and extinguishing small fires.
- **Medical operations:** Conduct triage, establish medical treatment areas, and provide basic first aid for victims.
- **Basic search and rescue:** Learn search and rescue planning, techniques, and rescuer safety.
- **Terrorism Awareness:** Define terrorism, terrorist goals, weapons, and indicators of a terrorist attack.

CERT's Role in the Community

The Charlotte CERT program has a role for everyone. Members use a combination of CERT training and community knowledge to serve their neighbors in a time of disaster.

Charlotte County has over 400 CERT members that serve the community during a disaster as shelter workers, call center operators, and as a support role during wildfires. CERT members also participate in public outreach events, support Fire & EMS by providing first aid at large events and provide lifesaving training throughout the community.

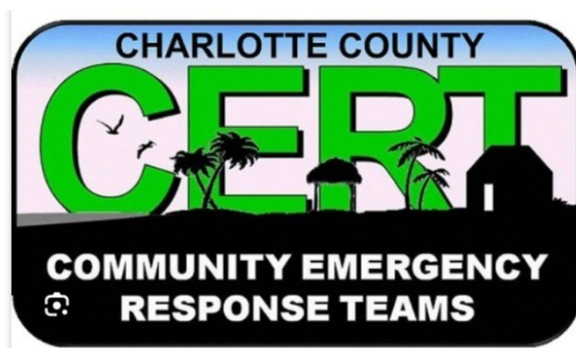
Become a CERT Member

The three-day Basic Training is scheduled on a quarterly basis. Training is at no cost and open to the public. Anyone under 18 needs to fill out a [parent consent form](#) to attend training. For more information about the program, email CharlotteCountyCERT@gmail.com.

The Rotonda CERT (Community Emergency Response Team) consists of about 40 volunteer residents that have completed the Charlotte County Emergency Management 3-day certification classes.

We can individually be **ACTIVATED** by Charlotte County, to respond to various emergencies to assist first responders. John Blanchette from Boundary Road is the team lead, Bernie Schmelz, former RWA resident, is also a leader and ham radio operator Doug Frazer, from Cape Haze and Sam Besase from Rotonda Circle also are in leadership roles.

Sam Besase says that he's been deployed about 2-3 times per year during his 12 years with Charlotte County CERT. Brush fires, hurricanes and other disasters are the primary reasons. In addition, there are quarterly training sessions for specialized training such as Call Center support and fire fighter rehab during disasters and shelter management emergencies.

The Rotonda CERT also puts on local CPR and AED and Stop the Bleed classes at the RWA Community Center. The Charlotte County CERT volunteers provide support for medical assistance during large local events such as the Sir Show and Waterfest.

We are always looking for more Rotonda volunteers.

We have a Rotonda CERT trailer located at the RWA maintenance area that we continue to equip with medical supplies and debris clearing materials such as shovels and tools.



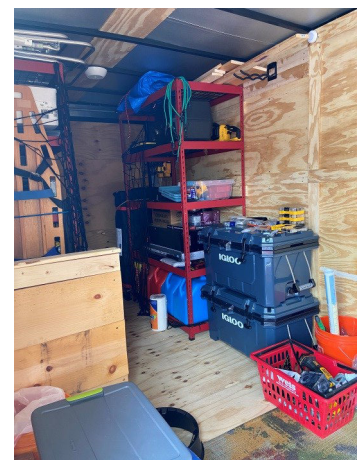

BROADMOOR PARK'S BUTTERFLY GARDEN IS BLOOMING

Come and enjoy the trails and the garden

In February, many new plants were added to the Butterfly Garden, including host plants for Monarchs, Cloudless sulphurs, Gulf fritillaries, and Zebra longwings. Volunteers also planted a native plant garden adjacent to the new community patio with nectar plants for pollinators.

As shade is essential to help plants through the very hot summer months, five trees were added in the spring: two live oaks, a southern magnolia, a Geiger tree and a fiddlewood. In June, more native plants were added, including some ground covers. Some bamboo trellises were added for climbing plants, and the Broadmoor birdbath is now in the Butterfly Garden. Mulch has been added to cool the soil, keep down weeds and define the garden edges. Blooming are zinnias, pentas, beach verbenas, black-eyed susans, liatris, salvia and blanket flowers. Visiting butterflies are Monarchs and Gulf fritillaries so far.

The Butterfly Garden team has plans for adding more mulch, ground cover and nectar plants, because butterflies need food also. We are constantly tackling the weeds. Garden volunteers create edges, plant, deadhead spent blossoms, select future plants and weed. Prospective volunteers can email Ann Weaver at ann.weaver815@gmail.com for more information.

Tim Dowd is back with us for game night.

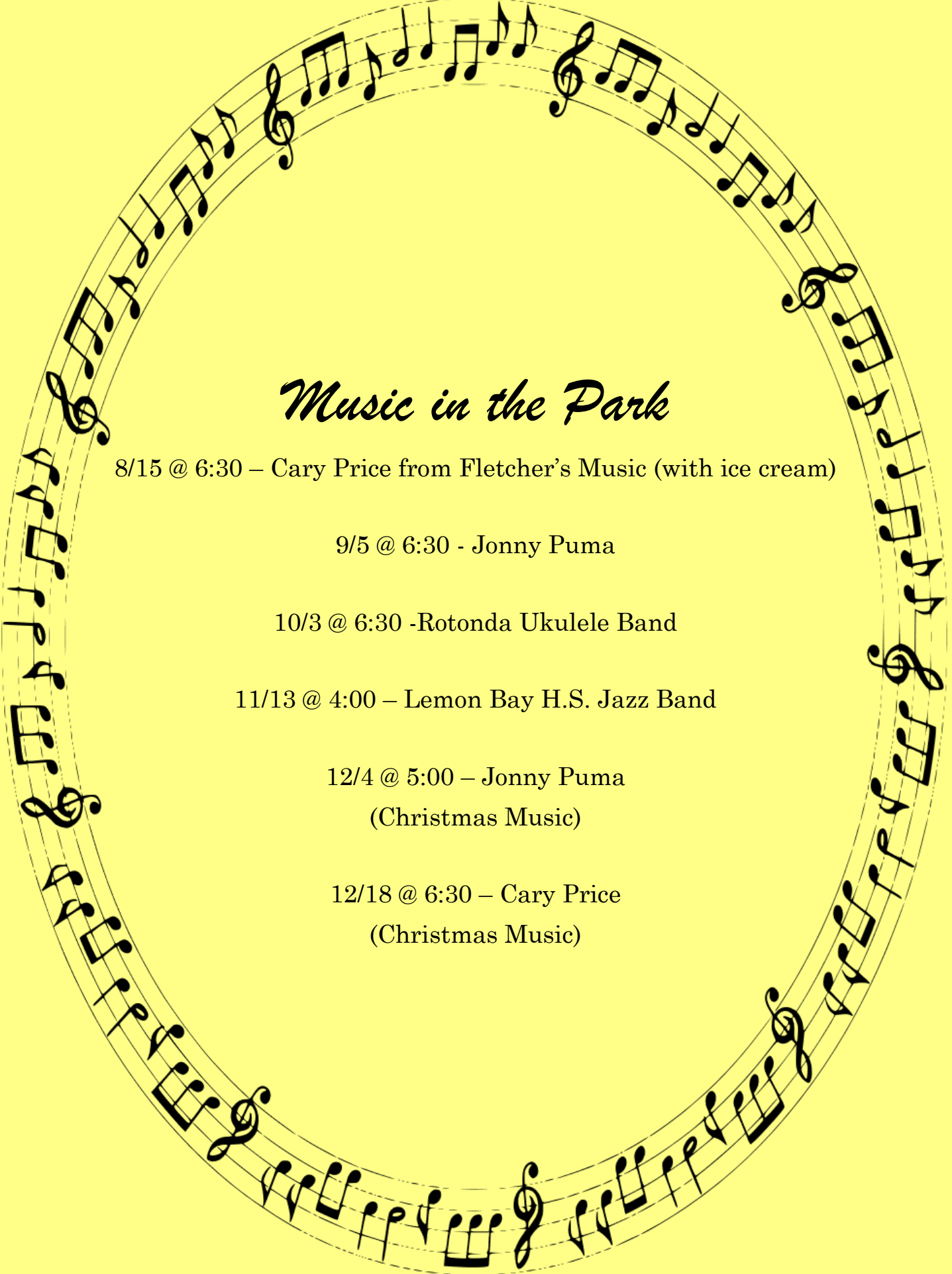

Is someone taking care of your home while you are away?? According to the Charlotte County Sheriff's Office, Home Security depends on good visibility. Plants should be kept trimmed, especially around doors and windows where someone could hide. One of the best sources of protection around your home is exterior lighting, ones that are motion-sensored or ones that come on at night. Make sure you have a neighbor or property management company keep an eye on your home while you are away.

Beware of a New Text Message Scam:

Recently those with the Florida Sunpass have been receiving text messages similar to this, *"Florida Sunpass, our records indicate that your vehicle has an unpaid toll invoice. To avoid additional charges of \$\$75.90 please settle your balance \$7.59 at <https://sunpasstollbill.com>"* This is a scam, do not click on the link. Notice the typos in that text; an outward sign of it being fraud. If you need to check your balance always do it through your computer OR a new web browser on your phone...

Beware of Skimmers at Gas Pumps

A few tips to avoid a skimmer scam; (1) make sure the gas pump panel is closed, (2) wiggle the card reader to check if it is loose, and (3) THEN insert your card.

-If you are concerned about being scammed at the pumps, you can always pay inside.

-Monitor your credit card statements regularly for unwanted charges and report those immediately. Don't forget to request a new credit card.
