Funds for the proposed building expansion are coming from current RWA CDAR accounts.

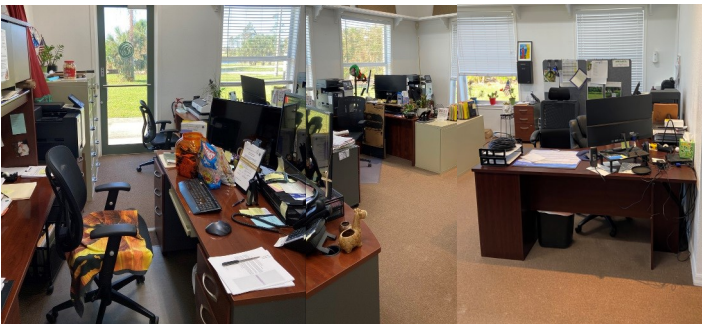

2024 RWA ELECTION UPDATE

By now, most of you have received your 2024 election packet which includes a blue absentee ballot, a blue ballot envelope and a pre-addressed white outer envelope marked with your corresponding Lot/Tract information. In the event you are missing any of those components, you can obtain replacements at the RWA office, 646 Rotonda Circle.

If you haven't received your packet yet, it may be because it's mailed to the address you have on file at the RWA office. If you are a seasonal resident and the RWA has your permanent address, then the packet will have been sent to that address. Again, should that be the case, you can obtain replacement materials by visiting the RWA office.

It is important to note that the owner of Lot/Tract must sign their name on the white outer envelope. Failure to do so will void the ballot. If you do not want to mail that signed envelope, you can drop it in the election drop box located in the lobby of the RWA office.

Should you prefer to vote in-person, you may do so at the Annual Meeting on Thursday, December 5, 2024. The in-person voting station, located in the lobby of the Community Center, will be open from 6:00 p.m. to 6:45 p.m. You will not need your blue absentee mail-in ballot, different ballots will be provided for in-person voting.

PLEASE EXPLAIN “ROLLOVER OF EXCESS RWA HOA FUNDS” WHICH APPEARS ON THE BALLOT EACH YEAR

Property owners are asked each year as a part of the RWA election process to VOTE either YES or NO to rollover excess funds. Here is Geoffrey Lorah’s (RWA’s outside independent CPA auditor) explanation:

1. Common interest realty associations (primarily condominium and property owner / homeowner associations) are organized as not-for-profit corporations. For operating purposes, it is assumed the annual budgets for these associations will be prepared on a break-even basis, meaning expenditures will equal revenues. When an association has excess member revenue in any given year, there are three basic options available to the association regarding the treatment of the excess revenue:
 - A. Refund the excess revenue on a pro rata basis to the members of the association
 - B. Obtain member approval to “rollover” the excess revenue to the subsequent fiscal year
 - C. Retain the excess revenue and report this revenue as taxable income on the association’s Federal and/or State tax return
2. If the members do not approve the rollover of the excess revenue, an association has two options regarding the treatment of the excess revenue; either refund it to the members or report it as taxable income.

Please note: This is a general explanation. The rollover process is primarily based on the requirements of IRS Revenue Ruling 70-604

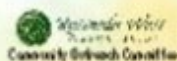

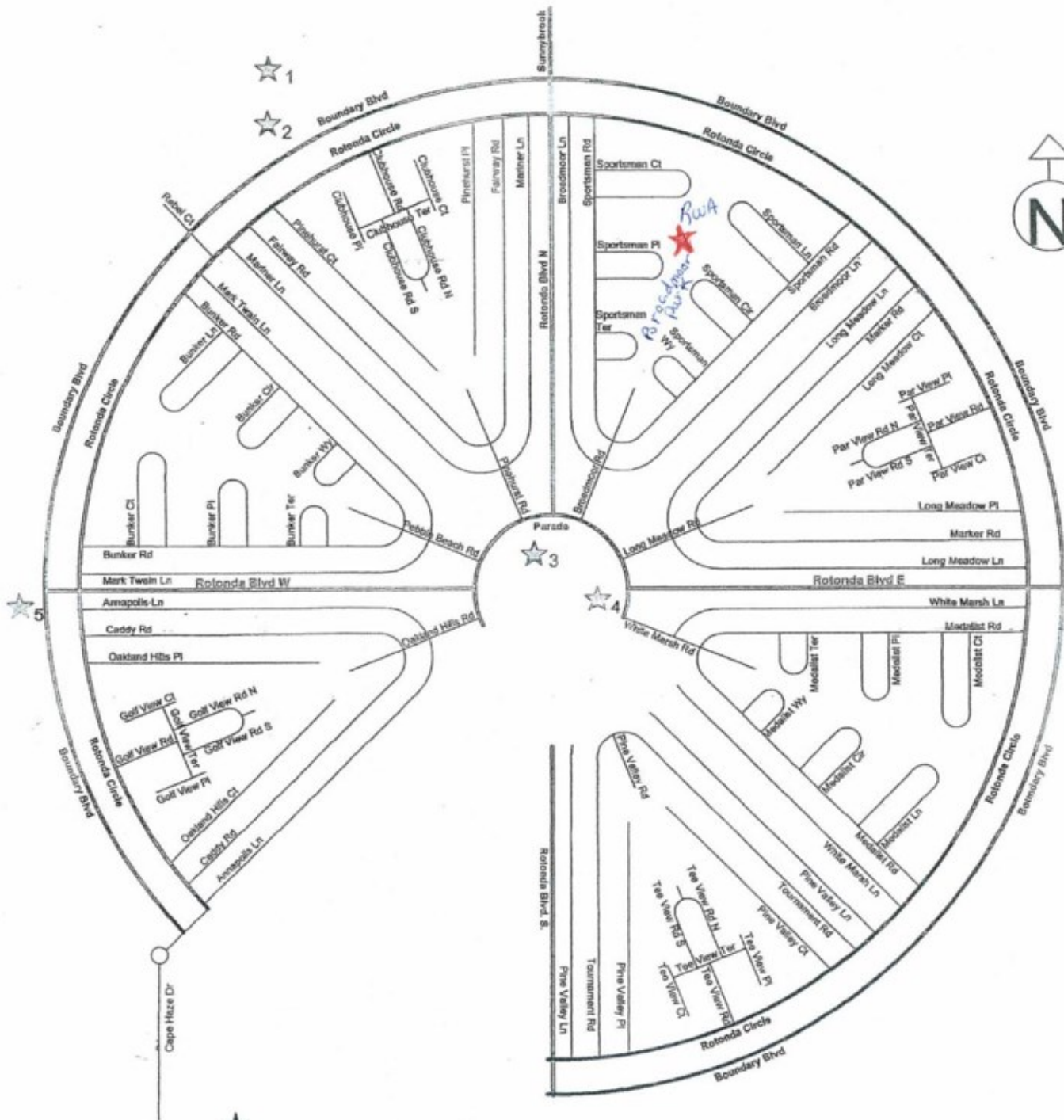

CHARLOTTE COUNTY NEWS ITEMS

Charlotte County Commissioners have approved purchase order contracts for work to be performed on the next 6 MSBU bridges here in Rotonda West:

- 1. Rotonda Bridge #014101:
NEAR 517 ROTONDA CIRCLE—Between Fairway Road & Mariner Lane**
- 2. Rotonda Bridge #014107:
NEAR 727 ROTONDA CIRCLE—Between Long Meadow Lane & Marker Road**
- 3. Rotonda Bridge #014104:
NEAR 563 ROTONDA CIRCLE—Between Broadmoor Lane & Sportsman Road**
- 4. Rotonda Bridge #014100:
NEAR 407 ROTONDA CIRCLE—Between Fairway Road & Mariner Lane**
- 5. Rotonda Bridge #014063:
NEAR 211 ROTONDA CIRCLE—Between Bunker Road & Mark Twain Lane**
- 6. Rotonda Bridge #014060:
NEAR 45 ROTONDA CIRCLE—Between Caddy Rod & Annapolis Lane**

The next 6 bridges work should start in November/December of 2024 and be completed by the end of the 1st quarter of 2025. Thus, at that time there should be 10 of the 18 bridges completed. It takes approximately 6-8 weeks to complete repairs and maintenance per bridge. Traffic shall be maintained. Please observe posted construction/detour signs. As you can imagine, Rotonda BRIDGE work has been delayed due to the recent series of Hurricanes (Debby Helene-Milton).

***4 completed – 14* more MSBU bridges to be completed.**

The construction work schedule for the bridges over the Rotonda River at ROTONDA BLVD NORTH and ROTONDA BLVD EAST and ROTONDA BLVD WEST shall be provided by Charlotte County at the December 2024 MSBU meeting.

These 3 bridges are paid for by the Charlotte County GAS TAX fund, NOT paid for by this MSBU.

***The latest news on the Hurricane Ian damaged ROTONDA BLVD SOUTH BRIDGE is that in April of 2024, the Charlotte County Commissioners wrote a letter to the US FEMA Director in Washington DC, asking for her review and expedited resolution for this bridge. Also, congressman Greg Steube is engaged in resolving this issue between FEMA and Charlotte County. NO NEW NEWS!!!**

The issue is money: \$312K – FEMA vs \$1.2M Charlotte County.

I am in continuous follow up in person and by phone and email on this topic with the Charlotte County Commissioners. There is no additional news yet.

- **Bridge Rehabilitation #4 - #014101** (Rotonda Circle/Pinehurst Creek N) and **#014104** (Rotonda Circle/Broadmoor Creek N) and **#014107** (Rotonda Circle/Long Meadow Creek S) – Thomas Marine Construction **to begin work shortly.**
- **Bridge Rehabilitation #5 - #014060** (Rotonda Circle/Oakland Hills Creek) and **#014063** (Rotonda Circle/Rotonda Ch. 32-1) and **#014000** (Rotonda Circle/Pinehurst Creek S) -- Thomas Marine Construction **to begin work shortly.**
- **Bridge Rehabilitation #6 – Bridges 014105 and 014106 – Weiler Engineering Corp. will soon present 100% design plans.**
- **Bridge Rehabilitation #7 – Bridges 014100, 014112 and 014123 – Request for design bids in progress.**
- **FEMA Bridge 014113 – design completed. Bridge 113, damaged by Hurricane Ian, is eligible for FEMA funding, which was denied. County engineers are appealing.**

CHARLOTTE COUNTY UTILITIES (CCU) – PROPOSED RATE INCREASES:

The Charlotte County Commissioners did not approve the proposed CCU water rate increases, instead the Commissioners sent the issue back to CCU and Administration for downward and stretched out revisions over the next 10 years. A Public Hearing might be scheduled in the fall of 2024 regarding this issue.

I am happy to report that in the last 6 weeks, a large section of SR 776 now has operating streetlights (between Farlow's & Gillott-about 8 miles). More sections of SR 776 lighting will become operational in the coming months. This is a great start. However, the latest round of hurricanes has toppled some of the new street lights, though not nearly as extensive as Hurricane Ian.

TRAFFIC LIGHT: The intersection of Gasparilla & Rotonda Blvd East is slated for a traffic light. There are supply chain issues, therefore, the traffic light (being paid for by the new high-end RV park), is about 6 to 9 months from installation (~spring 2025). Charlotte County has issued a purchase request to interested bidders.

2 VACANCIES IN LOCAL MSBU'S:

Rotonda West Street & Drainage Unit-MSBU seeking one member to fill position. Term thru 10/31/2027.

West Charlotte Stormwater Unit– MSBU seeking one member to fill position. Term thru 10/31/2027.

The last quarterly Rotonda West Streets & Drainage meeting was held on **Thursday June 20, 2024**. The next MSBU meeting was cancelled due to Hurricane Milton and the next MSBU meeting is on **December 19, 2024** at San Casa.

- **The Paving Schedule for the roads here in the Rotonda West MSBU might be accelerated to perhaps Spring of 2025. GREAT NEWS!**
- **New Fish Barriers in the Rotonda River near Rotonda Blvd South have been installed, they were damaged during Hurricane Ian.**
- **The 14 streetlight poles on the 4 bridges over the Rotonda River have been repaired/replaced. RBN & RBE & RBW & REBEL COURT**
- All Rotonda Bridges are currently structurally sound
- Rotonda West bridges (all are over 40 years old), they are rated at 80,000 lbs. GVW.
- Residents or their contractors are **MOWING** all the way down to the Ponds, this practice is **not recommended** by FWC or SWFTMUD or Charlotte County.
- Also, Residents or their contractors are **FERTILIZING** all the way down to the Ponds, this practice is **not recommended** by FWC or SWFTMUD or Charlotte County.
- Also, residents are leaving their **GRASS CLIPPINGS** in the roadway, this practice is **not recommended** by FWC or SWFTMUD or Charlotte County
- Charlotte County Commissioners alerted residents that there is **TOO MUCH NITROGEN** in local waterways.

The Charlotte County Commissioners met recently regarding Proposed MSBU Rates for 2025:

There are **2** MSBU's (Municipal Services Benefits Unit) that apply to RWA residents:

- 1. ROTONDA WEST STREETS & DRAINAGE MSBU:**
- 2. WEST CHARLOTTE COUNTY STORMWATER MSBU:**

The MSBU rates for both of the above MSBU's here in the Rotonda area shall remain the same – **NO INCREASE IN MSBU RATES.**

Paving

-Potholes

- 471 Rotonda Circle — Work order 12250 for pothole repair
- 100 Rotonda Circle -- Service request 12534 for pothole repair
- Road and Bridge gas tax paving -- The Board of County Commissioners approved the award of the [paving contract](#) in September. The **Boulevards and Parade Circle** will be paved in the next few months. Standard crosswalks will be installed. If the advisory board desires stamped asphalt crosswalks instead, the MSBU would pay \$35,600 or about \$4 per property. 9,000 properties x \$4 = ~\$36,000.

MSBU Paving 2025 - The 2025 MSBU paving program will go out to bid soon. The chosen contractor will decide where in its schedule to place Rotonda West. I will keep you apprised.

Drainage

We had a wet summer! From June – August, [43 inches](#) fell. Then Tropical Storm Debby and Hurricane Helene and Hurricane Milton!

Charlotte County advised that the plan is to put a segment of **Greenway** out for bid this fall for ditch maintenance. From there, the County can estimate what the entire greenway would cost to remediate and create a multi-year budget to do so. That would mean an increase in MSBU rates probably in 2026.

Pipes to be lined in advance of paving (3 pictures attached)

- Rotonda Blvd E @ Crevalle Road near Fiddlers Green, line from catch basin to canal – done
- Rotonda Blvd E @ Cape Haze trail head – line road crossing pipe – done
- Sunnybrook Blvd @ Greenway Ave – line double barrel pipe – in progress.

There are **DOZENS** of open drainage work orders in Rotonda West. Public Works will get to all of them. These are a few that I have asked about lately.

- 84 & 86 **White Marsh Lane** - Open WO 59974 for swale grading at 94 White Marsh Ln. 84 & 86 added.
- 248-250-252-254-256 & 252-253 **Rotonda Blvd North** -- This was investigated in June. In July, vegetation was removed from outfall at 253 RBN. WO 57242 is in place for vacuum culvert cleaning from 249 to 263 RBN. Menzi Muck work order 57964 is in place.
- 2 & 4 **Oakland Hills Ct** - Broken pipe. Water from 2 ponds are overflowing into resident back yards. On 9/23, an inspector put safety tape around the pipe and issued WO 70269 for small pipe install at #4 Oakland Hills.
- **33 Clubhouse Rd** - Service Request 11949 has been created to address the drainage issue in front
- **243 White Marsh** – CCU sewage backup.
- **248-250-252-254-256 & 252-253 Rotonda Blvd., North**, Drainage issues
- **59 Pine Valley Lane** – Drainage issues.

I hope that answers many of your questions between now and the next meeting on December 19, 2024, where you'll see the annual presentation on the Rotonda West work program.

Decorative Lighting throughout RWA – A citizen in the Pinehurst section submitted a request for the MSBU advisory board to consider decorative lighting like the kind at Manasota Key.. He was advised by the County that specialty lights need to be requested and funded through the Rotonda West Streets & Drainage MSBU.

The coyote is a member of the dog family, weighing between 20 and 30 pounds with pointed ears, a narrow muzzle, and bushy tail. Pelts are usually grayish-brown with a patch of white chest hair. When running, coyotes usually hold their tails downward and tracks are narrower and more elongated than dog tracks.

Coyotes are native to North America and began expanding into northwestern Florida in the 1970s. They are now considered to be a naturalized species in all 67 Florida counties. They are extremely adaptable; just about any type of forest or farmland, suburban and urban areas, is suitable habitat.

The scientific name of the coyote, *Canis latrans*, literally means "barking dog." Coyotes make a variety of vocalizations from barking to shrill yips and howls. They are active day or night, but usually most active at sunset and sunrise.

Coyotes are territorial. A resident pair will establish a territory shared only by other members of their family group.

Coyotes eat a variety of plants and animals including fruits, insects, rats and mice, rabbits, birds, deer, livestock, virtually any type of carrion, trash and pet food.

Coyotes have one breeding cycle per year and can first breed when they are 10 months old. Breeding occurs in late winter and following a 63-day gestation period, 4 to 6 pups are born. Parental care lasts until the pups are about 9 months old, when the young usually disperse to a new area and establish their own breeding territories.

Follow these tips to avoid conflicts.

- Feeding coyotes is illegal. They will lose their fear of humans.

- Secure garbage cans. Clean up pet food and fallen fruit.

- Secure livestock in predator-resistant enclosures.

- Keep pets in enclosed areas. Walk dogs on a short leash.

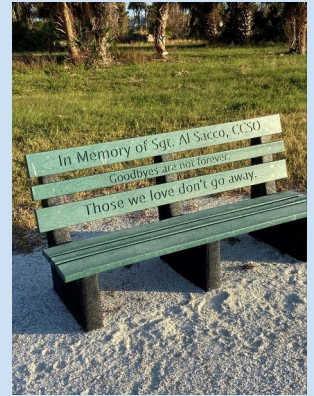

Sgt. Sacco represented the ideals of the Charlotte County Sheriff's Office and will be remembered for his contributions around the agency and throughout the community.

In 1907 the railroad was completed to Boca Grande, and for the next 50 years shipped phosphate out of Port Boca Grande. In 1969 Port Boca Grande ranked as the fourth busiest port in Florida. Today it stands abandoned.

PRESENTATION DESCRIPTION:

In the late nineteenth and early twentieth century, Southwest Florida experienced a level of development not seen before. Join Dr. Jennifer Zoebelein, Historian for Charlotte County, as she discusses the rise of the phosphate industry in the region and its direct connection with the growing development of railroad networks across Florida. This industrial growth brought economic growth and opportunity to Charlotte County, fostering the creation of new towns and increased population growth, and stands as one of the more important moments in our region's history.

SPEAKER BIO:

A native of Long Island, Dr. Jennifer Zoebelein is the historian for Charlotte County, a position she's held since November 2019. She received her PhD from Kansas State University in 2018, where she examined how the United States commemorated the First World War. Prior to moving to Florida, Jennifer worked for the National World War I Museum and Memorial in Kansas City and the World War I Centennial Commission. She has also worked for the National Park Service at Fort Sumter National Monument and the New York Historical Society. Jennifer has a long-standing passion and interest in history and enjoys reading and researching local and state history.

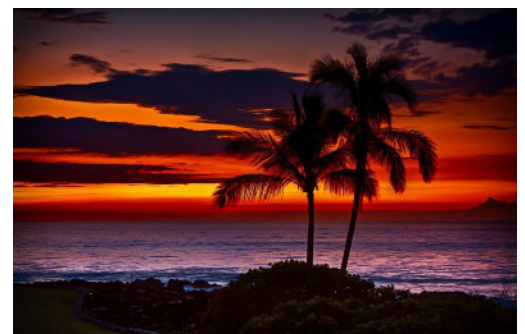

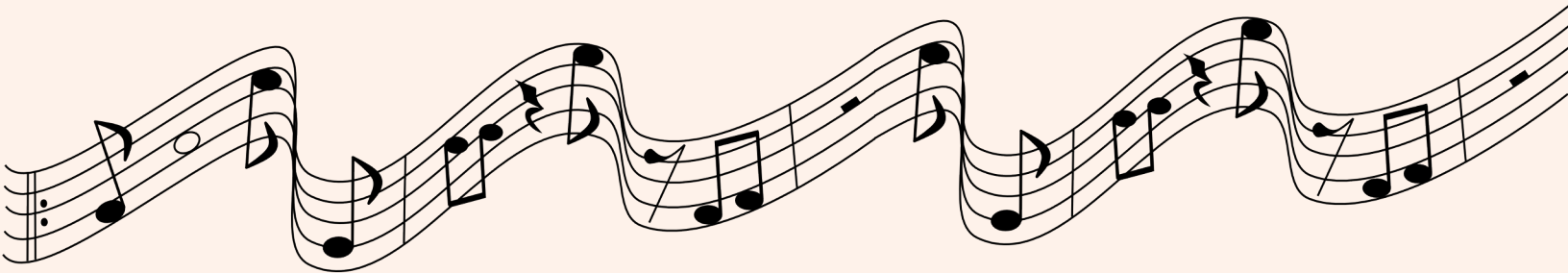
