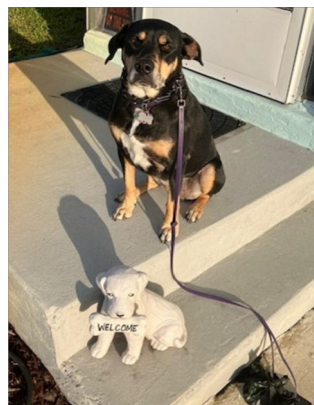
Residents of Rotonda West sent in some great pictures of their faithful companions enjoying special time together with their owners.

RWA Board to Approve Electronic Voting and Electronic Noticing

At its meeting on March 13, 2025, the RWA Board of Directors will approve a resolution to enable RWA members to cast their votes for Board candidates and association issues electronically and to receive electronic notices of Board, committee and Annual Meetings.

Members choosing to vote electronically will be able to avoid the hassle of folding the paper ballot, inserting it into multiple envelopes, stamping the outer envelope and then mailing the package. Instead, they will be directed to an election website where they can review election-related information, including an explanation of any issue that may be on the ballot as well as each candidate's information. Members choosing electronic noticing will receive Board and committee meeting notices as well as the entire Annual Meeting notice package electronically.

By now you should have received a mailing from the Association that contains a copy of the resolution, a copy of the consent form you would use to opt in to electronic voting and or electronic noticing or both. There is also a copy of the revocation form you would use to opt out of either electronic voting or noticing or both. Both the Board and the Election committee urge you to opt in to both electronic voting and electronic noticing. We believe this is an option that will simplify voting for Board-related issues and by doing so it will increase member participation in elections. For your convenience, this mailing includes a self-addressed stamped envelope which you can use to return your consent forms.

If you haven't received your mailing yet, you can view copies of the resolution, the opt in form for electronic voting and noticing and the revocation forms by logging on to the RWA website and selecting *RWA Elections* under the *Governance* heading on the home page.

As always, both the Board and the Election committee appreciate your participation in the RWA election process and look forward to adding the convenience of electronic voting to the traditional paper mail-in ballot in 2025. Everything You Need to Know about Electronic (Online) Voting in Florida

“Associations are discovering huge advantages by implementing electronic voting for their members pursuant to Florida Statutes §718.128 (for condominiums) and §720.317 (for homeowners associations). Among other benefits, voting online saves costs to associations, increases member participation, eliminates dishonesty and human errors associated with paper votes, decreases meeting times, and greatly improves the process of inspections, as well as potential recounts. Consenting owners in Florida can also receive notices by electronic (email) transmission, which significantly reduces costs associated with printing, envelopes, postage, copies, and administrative time.



Voting online and sending electronic notices by email is instantaneous and costs much less to associations. Due to less actual counting of physical ballots, meeting times are also shortened through the use of electronic voting, and associations can therefore reduce unnecessary expenses for attorneys, monitors, and other staff having to attend longer meetings. Instead of inspecting and counting ballots for hours, the electronic results are displayed and confirmed in just seconds. Most importantly, members can vote conveniently from their computers or mobile devices anywhere in the world.

Online voting in Florida, however, must be done in strict compliance with the applicable statutes. As such, it is imperative that associations use a reliable, proven, secure, and legally compliant electronic voting system. Associations should not take risks with software that intermittently fails, only has a limited number of users, or was not created by a qualified lawyer.

Under Florida Statute §718.128 (for condominiums), an association must provide each owner with (a) a method to authenticate the unit owner's identity to the online voting system; (b) for elections of the board, a method to transmit an electronic ballot to the online voting system that ensures the secrecy and integrity of each ballot; and (c) a method to confirm, at least 14 days before the voting deadline, that the unit owner's electronic device can successfully communicate with the online voting system. Moreover, Florida law only allows associations to conduct elections and other unit owner or member votes through an internet-based online voting system if a unit owner or member consents, in writing, to online voting and such software system meets certain legal requirements. Note that the applicable homeowners association statute, §720.317, is substantially similar.

The law also requires associations to use an online voting system that is (a) able to authenticate the unit owner's identity; (b) able to authenticate the validity of each electronic vote to ensure that the vote is not altered in transit; (c) able to transmit a receipt from the online voting system to each unit owner who casts an electronic vote; (d) for elections of the board of administration, able to permanently separate any authentication or identifying information from the electronic election ballot, rendering it impossible to tie an election ballot to a specific unit owner; and (e) able to store and keep electronic votes accessible to election officials for recount, inspection, and review purposes.

There are also legal and technical requirements to getting started with online voting. For example, in order to implement electronic voting, associations must formally adopt a (one-time) board resolution authorizing an online voting system and establish procedures and guidelines for unit owners to consent in writing to online voting and opt out later, which is often accomplished using promulgated forms prepared by an attorney. Written notice of the meeting at which the resolution will be considered must be mailed, delivered, or electronically transmitted to the unit owners and posted conspicuously on the condominium property or association property at least 14 days before the meeting. A unit owner's consent to online voting is valid until the unit owner opts out of online voting according to the procedures established by the board.

It is often critical for associations to achieve certain votes, such as for capital improvement projects, elections of directors, and waiver of reserves. Electronic voting increases member participation, in large part, due to the convenience of members being able to vote online from any device with internet access as well as the ability to send electronic reminder notifications. On average, online participation is often as high as 60–80 percent compared to many associations that struggle to achieve 20–30 percent participation from physical balloting. Although some owners will prefer to continue using physical votes (and may do so by law), the online votes help associations achieve quorum requirements and/or certain required percentage votes.

Online voting is also beneficial as it may eliminate cheating and human errors because owners can only submit one secure, verified ballot. Good online voting systems can also cross-reference, detect, and prevent duplicates where owners may also try to vote in person. Additionally, owners cannot make mistakes in casting their electronic ballots like they do with physical ones where, for example, they may forget to sign the outer envelope properly or fail to include the sealed inner envelope; in both these instances for condominiums, the votes must be disregarded. Once an online vote is received, it is automatically counted correctly by the electronic voting system.

Some of the best online voting software systems also offer associations other communications tools and features, such as the ability to live stream and record meetings, send verified (tracked) emails, and survey members. Streaming and recording association meetings to the members in a password-protected portal is a new best practice standard that can provide maximum transparency and accountability for boards. Online surveys can also be a great way to get the community involved and provide members' input without taking an official vote.

More and more associations are implementing electronic voting for their members every day, and this trend will inevitably increase. Some things to look for when selecting the right electronic voting software provider include whether the company (a) provides software that is 100 percent legally compliant and was created by a qualified attorney; (b) has a cyber insurance policy with a well-rated carrier to protect against data breaches; (c) has an effective method for cross referencing physical and online ballots (in order to prevent any duplicates); (d) has in-house legal counsel; (e) has a program that is proprietary, and does not utilize other third-party features which are more susceptible to problems and security risks; and (f) has a large enough support staff to provide all technical and other support your association needs.

The benefits of electronic voting are limitless! Has your board implemented it for your association members yet?"

DID YOU KNOW?

There have been small physical changes made here in Rotonda over the past few months, putting your HOA fees to work. The marina island bridge was repaired last fall, just in time for our annual Gazebo Lighting and Boat Parade event. Some of its condition was due to wear and tear and some due to the hurricanes over the past few years. Now, it is once again safe to cross over to the island and gazebo.

The area in front and behind the administrative office and community center has seen some upgrades, too. There are additional solar security lights for the parking lots and behind the buildings. A few trees have been added to replace some that were lost due to hurricane damage. The butterfly garden and the native plants garden are being improved and maintained. In the gardens identification tags have been added by some of the plants so you know the names and whether they are a host or a nectar plant for butterflies. We had 11 Monarch Butterfly caterpillars in the garden last month and many more butterflies seem to find the garden each month.

If you're wondering what that wide path is at the entrance to Broadmoor Park, it is a maintenance road. A dedicated, unpaved road for our large RWA equipment, plus FEMA and county debris removal trucks. The road will also be used for construction equipment to bring materials for the addition to the administrative office. And, if we ever need it, it will serve as an emergency entrance/exit should the main paved road ever be blocked. The plan is for this to take some of the wear and tear off the paved entrance road which leads back to the administrative office and the community center.

Three TVs have been added in the community center. One in the foyer which will have scrolling messages of coming events. Plus, two in the center of the main room so presentations and games (bingo & trivia) may be more easily seen by those sitting in the middle of the room. We already have two at the front and two at the rear.

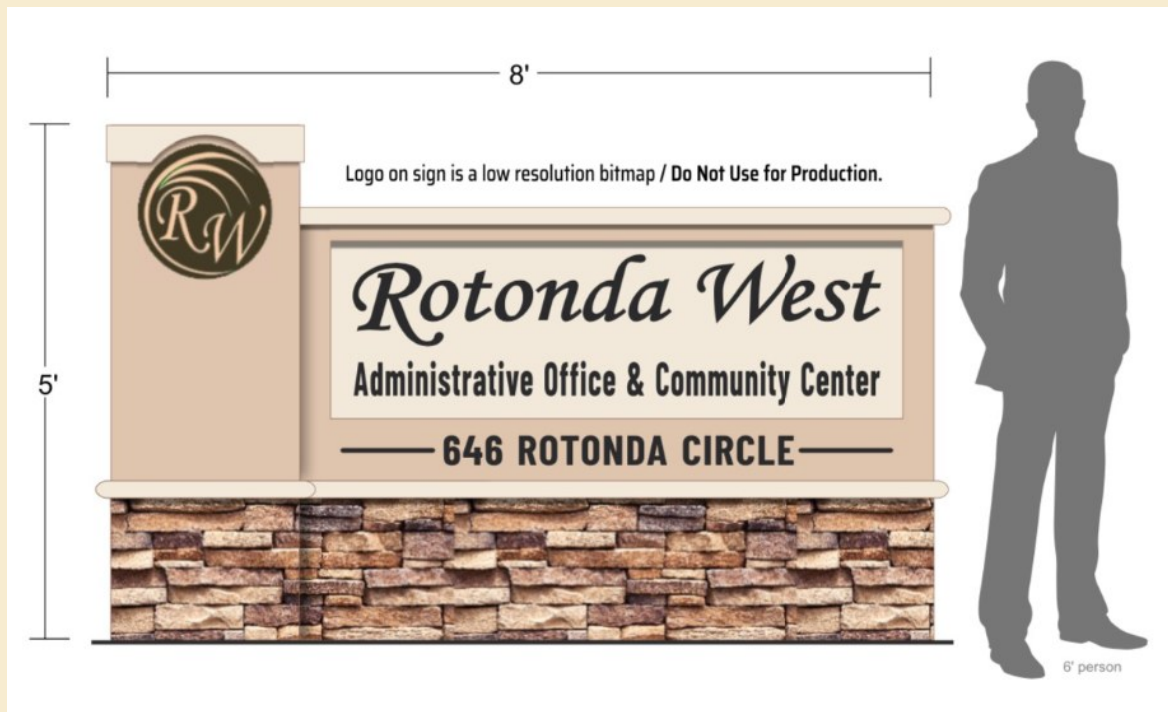
Staff is updating policy and procedure documents. They are also replacing batteries in the exit signs, painting the buildings (same color), installing more fire boxes which hold the fire extinguishers. Repainting the interior of the buildings is now complete.

Coming soon, a contractor will be repairing the parking lot asphalt near the administrative office, community center and at the marina, with sealing and striping work to begin in April. Although, not paid by our HOA fees, the county roads which pass through Rotonda have been repaved. East, West and North Boulevards, plus Parade Circle. They even have reflector strips to separate the lanes.

CHARLOTTE COUNTY NEWS ITEMS

- Paving of the GAS TAX ROADS/BRIDGES started on January 6, 2025.
- ROTONDA BLVD NORTH–ROTONDA BLVD EAST–ROTONDA BLVD WEST–PARADE CIRCLE
- The Paving Schedule for the other 60 plus miles of roads here in the Rotonda West MSBU shall probably begin in the 4th quarter of 2025. GREAT NEWS!
- Standard crosswalks were installed at the 6 crosswalks on Parade Circle much to the dismay of many residents.
- The election of MSBU Officers has been deferred until the March 27, 2025 meeting.

The Rotonda BRIDGE work shall start again on March 10, 2025 and includes 6 bridges. The first bridge is on Rotonda Circle between Long Meadow Lane and Marker Road and very near Rotonda Boulevard East. Charlotte County and its contractor expect the next 6 bridges to be completed perhaps in the 3rd quarter of 2025.

Thus, at that time there should be 10 of the 18 bridges completed. It takes approximately 4 weeks to complete repairs and maintenance per bridge. Traffic shall be either detoured or maintained. Please observe posted construction/detour signs.

1. Rotonda Bridge #014107:
Near 727 ROTONDA CIRCLE Between Long Meadow Lane and Marker Road
 2. Rotonda Bridge #014104:
NEAR 563 ROTONDA CIRCLE–Between Broadmoor Lane & Sportsman Road
 3. Rotonda Bridge #014101:
NEAR 517 ROTONDA CIRCLE–Between Fairway Road & Mariner Lane
 4. Rotonda Bridge #014100:
NEAR 407 ROTONDA CIRCLE–Between Fairway Road & Mariner Lane
 5. Rotonda Bridge #014063:
NEAR 211 ROTONDA CIRCLE-Between Bunker Road & Mark Twain Lane
 6. Rotonda Bridge #014060:
NEAR 45 ROTONDA CIRCLE–Between Caddy Rod & Annapolis Lane
- 4 completed – 6 starting = 10 of 18* 8 more MSBU bridges to be completed.

Meanwhile, the construction work schedule for the bridges over the Rotonda River at ROTONDA BLVD NORTH and ROTONDA BLVD EAST and ROTONDA BLVD WEST shall be provided by Charlotte County at the March 27, 2025 MSBU meeting.

These 3 bridges are paid for by the Charlotte County GAS TAX fund, NOT paid for by this MSBU.

The latest news on the damaged ROTONDA BLVD SOUTH BRIDGE is that in early February of 2025, FEMA rejected the Charlotte County APPEAL, stating that there is photographic evidence thru Google Maps that damages were PRIOR to Hurricane Ian. Believe that Charlotte County plans to APPEAL the APPEAL while also pursuing funding sources to START the work on this bridge. We should know more about this at the March 27, 2025 MSBU meeting.

I am continuously following up in person and by phone and email on this topic with the Charlotte County Commissioners and Public Works personnel.

TRAFFIC LIGHT: The intersection of Gasparilla & Rotonda Blvd East is slated for a traffic light. There are supply chain issues, therefore, the traffic light (being paid for by the new high-end RV park), is about 6 to 9 months from installation (~fall of 2025). Charlotte County has issued a purchase request to interested bidders.

The next regular quarterly Rotonda West Streets & Drainage meeting shall be held on **Thursday March 27, 2024 at the San Casa Charlotte County facility**. The Charlotte County Paving Manager is supposed to attend.

Swale Drainage Issues:

We had a wet summer! From June – August, [43 inches](#) fell. Then Tropical Storm Debby and Hurricane Helene and Hurricane Milton!

Charlotte County advised that the plan is to put a segment of **Greenbelt** out for bid for swale ditch maintenance. From there, the County can estimate what the entire sections would cost to remediate and then create a multi-year budget to do so. That would mean an increase in MSBU rates probably in 2026.

Drainage Pipes to be lined in advance of paving:

Rotonda Blvd E @ Crevalle Road near Fiddlers Green, line from catch basin to canal – done

Rotonda Blvd E @ Cape Haze trail head – line road crossing pipe – done

Sunnybrook Blvd @ Greenway Ave – line double barrel pipe – in progress.

There are **DOZENS** of open drainage work orders in Rotonda West. Public Works will get to all of them.

I hope that answers many of your questions between now and the next meeting.

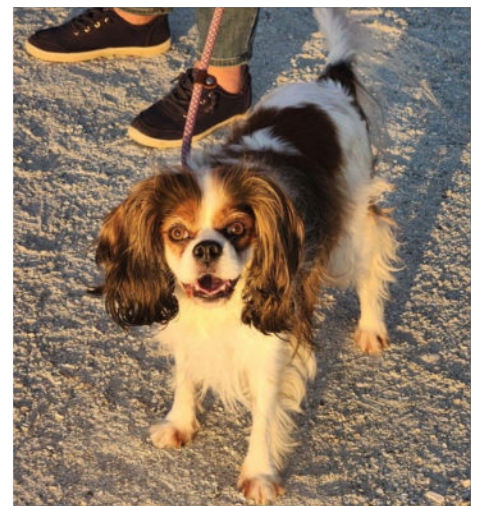

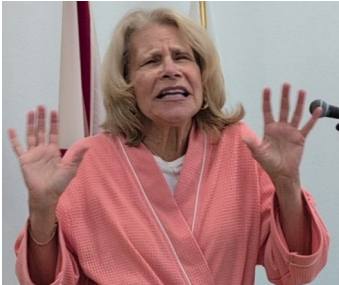

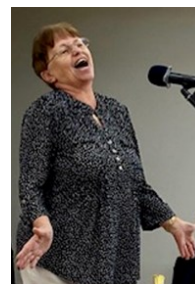

Gopher Tortoise

February 4, 2025



Program participants learned about one of the oldest creature on earth, the Gopher Tortoise, a state Threatened species and a keystone species, with a disproportionately large effect on it's natural environment. Gopher Tortoise burrows can provide shelter for over 350 other species. Gopher Tortoises are losing their high dry habitat to development. Amphibians

February 18, 2025



Amphibians are cold-blooded, vertebrate animals with an aquatic phase (gill breathing) and a terrestrial phase (lung breathing). <https://www.floridamuseum.ufl.edu/discover-herps/florida-amphibians-reptiles/>

Amphibians are crucial for the ecosystem by nutrient cycling and food chains. They act as both predators and prey, controlling pest populations and serving food for other wildlife, maintaining ecological balance.

Invasive Cuban tree frogs (shown on left above with large pads) are out competing the native green tree frog.

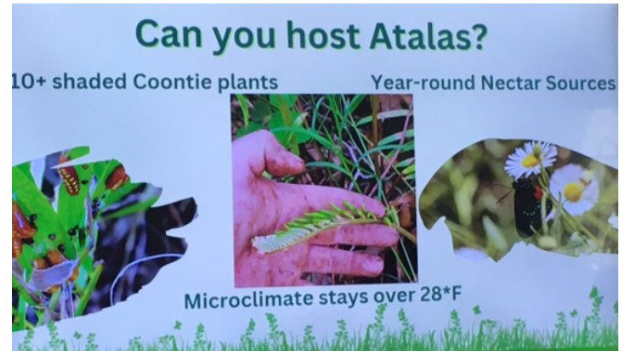
Rotonda West Community Outreach Nature Committee Presentation:

Atalas and Coonties

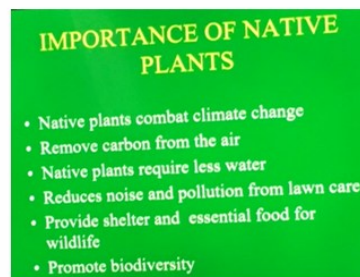

WHY PLANT NATIVE?

Speaker Jayne Neville, Mangrove Chapter of the Native Plant Society

Jayne Neville explained that without native plants, there would be no insects and without them there would be no wildlife. For example, birds and many other animals rely on insects to feed their young. Native plants also provide food and shelter for wildlife. Once established, native plants need minimal water and no fertilizer or pesticides which damage our natural habitat and waterways.

The Mangrove Chapter of the Native Plant Society is holding their annual plant sale March 1, 2025 9-11 at Lemon Bay Park 570 Bay Park Blvd, Englewood.

Attendees left the program with a free native plant for their yard!

ROTONDA WEST RESIDENTS RECEIVE FLORIDA FRIENDLY LANDSCAPING RECOGNITION

Sara Weber, Florida Friendly Landscaping Education and Training Specialist at Charlotte County Extension presented the Florida Friendly Landscaping Gold recognition to Bob and Merrill Horswill for their yard at 96 Fairway Road.

Native plants and trees predominate, with an emphasis on wildlife habitat and pollinator gardens. The empty lots on each side of the house are being restored to the original native pine flatwoods habitat that predates development. These lots received a Florida Friendly Landscape Wild recognition. The Horswill's property is the first to be recognized as Florida Friendly in Rotonda West.

To qualify, the landscaping must follow the Florida Friendly Landscaping principles below:

Nine Principles of Florida-Friendly Landscaping™

1. Water Efficiently, as needed
2. Fertilize Appropriately, if at all
3. Mulch with sustainable products
4. Attract Wildlife with plants that are native and Florida friendly
5. Control Yard Pests Responsibly, if needed
6. Recycle yard waste
7. Reduce Stormwater Runoff
8. Protect the Waterfront
9. Right Plant, Right Place

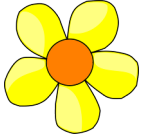

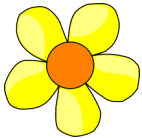

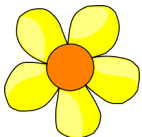
