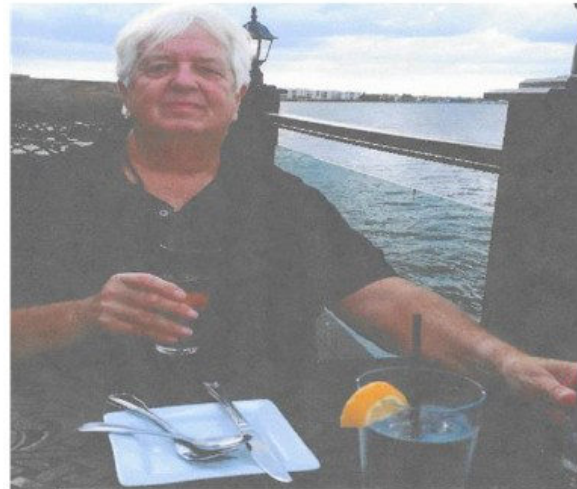

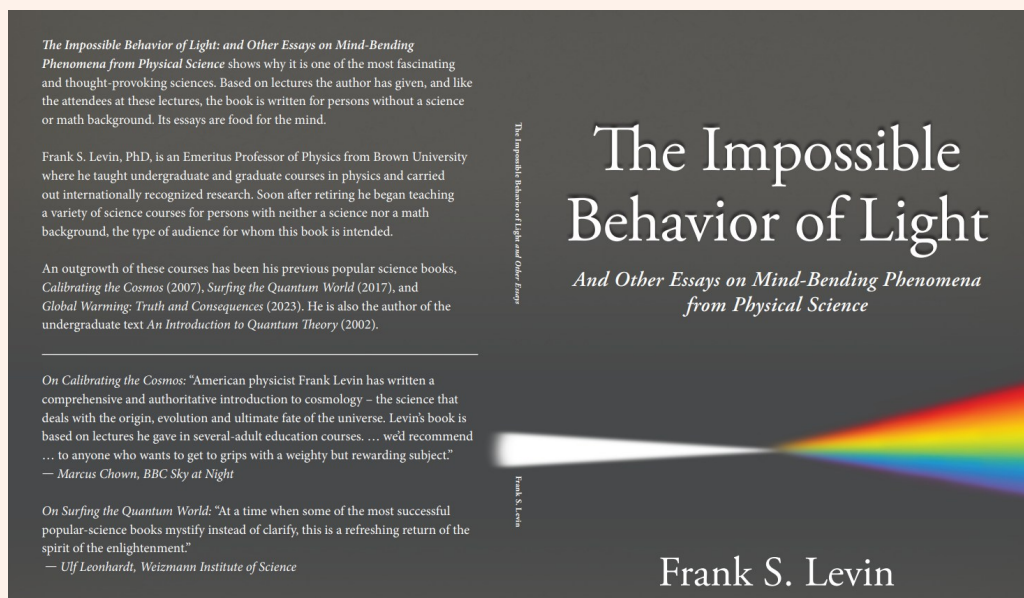
ROTONDA LECTURER & AUTHOR, DR. FRANK LEVIN RELEASES NEW BOOK

It has been a few years since Dr. Frank Levin gave a lecture at Rotonda Community Center, but the 92 year-old former Brown University physics professor has been busy. He has recently released a new book, The Impossible Behavior of Light. It is based on his 90-minute lectures delivered at the RW Community Center. He states that it is short, with many diagrams and tables, and that it was published by Amazon.

Dr. Levin's lectures series included: *Symmetry in Nature-Art and the Laws of Nature; Atoms are Real, Aren't They?*; *The Most Important Minus Sign in the Universe; Global Warming– Truth & Consequences*; and *The Impossible Behavior of Light*. The lectures reflected Dr. Levin's love of the science of physics and the importance of life-long learning. For those people who faithfully attended his lectures, our minds were indeed stretched by his analytical scientific explanations on the topics covered.

His resume is impressive. He has worked on several postdoctoral scientific research projects, has been a visiting professor all over the world, has chaired various scientific groups, and has written three popular science books. Now, The Impossible Behavior of Light, is added to the list.

STATUE OF LIBERTY COMES TO ROTONDA WEST

This **Statue of Liberty** is soon to be located at the new **Liberty Island** in Rotonda West, Florida – near the Gazebo that is located at approximately 108 Boundary Boulevard. Thanks to residents Todd Talley and Phyliss Stewart who live on Medalist Court, for the recent donation of this beautiful 8-foot-tall Statue of Liberty. As the picture shows, this Statue of Liberty stood in the front courtyard of the **Crescent Hotel in Eureka Springs, Arkansas** hotel for well over 100 years.

The **Crescent Hotel** became known as one of the most haunted places in the United States, thanks to Norman Baker. The man purchased the building in 1937 and decided to open a hospital and health spa for cancer patients. He was a charlatan and had no medical education but managed to attract dozens of patients over the course of about 10 years by advertising miraculous treatments. He eventually was jailed for fraud.

The **Crescent Hotel** is known as the most haunted hotel in the United States, and there have been several reports of paranormal activities in the building. People often say they see ghosts of doctors, nurses, patients, and even pets. The most haunted spot is Room 218, the same place that the stonemason building the hotel fell to death thus resulting in the first of many deaths at this hotel.

- Future issues of WEST WAYS shall include the projected start/finish for the remaining 2 RWA sections.
- Charlotte County Paving Project Manager is James Layport and his phone number is: 941-628-8084
- PERHAPS 30-45 DAY Paving schedule slips due to Weather & Equipment & Manpower issues.
- ROTONDA BRIDGE #13 – ROTONDA BLVD SOUTH – UPDATE:
- **Some important movement** – Army Corps of Engineers (ACOE) permit process is now out for 30 days of PUBLIC COMMENT, ending in late September, perhaps permit issued in late October.
- FEMA negotiations have started, and a report was provided to FEMA including updated project costs of about \$1.8M (vs \$1.1M 3 years ago), a 64% cost increase.
- Bid specification is ready to go out for bid, must wait for ACOE permit – perhaps November!
- Bid close perhaps Jan 2026, County Commissioners award contract perhaps 1Q 2026
- Construction start perhaps 2Q 2026, completion expected 10-12 months later – **Dec. 2026???**

- Rotonda Bridges Rehabilitation Status: Bridge #106 – Long Meadow, expected to be completed by 10/03/2025; Bridge #060 – Oakland Hills, expected to be completed by 10/18/2025
- Remaining 4 bridges, (#110-#111-#112-#123) are scheduled for summer/fall of 2026.

The COLLARS near the bottom of the STOP, are color coded and the color indicates the **evacuation** zone for that area and it includes a LETTER designation in addition to the COLOR designation. DIET IS A POWERFUL ANTI-AGING TOOL

A Health & Wellness Presentation

If you want to live longer, pay attention to your dinner plate, because you “can’t out-exercise a bad diet,” says Diane Casey. The licensed dietitian, nutritionist and health coach discussed “Eating for Longevity” before a large crowd, September 25, at the Rotonda Community Center.

Based upon the whole-food plant-based diet advocacy of Michael Gregor, M.D. FACLM, author of, “How Not to Age,” Casey discussed the eight anti-aging principles of food consumption:

1. Nuts

- Although walnuts are king, include almonds, cashews, peanuts, hazelnuts and Brazil nuts daily.
- Because nuts are high in calories and fat, watch your portion size, limit servings to 10 walnut halves, 13 cashews, 17 almonds and 25 peanuts. Never eat more than one cup of nuts per day due to oxalate content and potential for kidney stone formation.

2. Greens

- Leafy greens, including spinach, kale, arugula, beet and mustard greens, chard and cruciferous vegetables (broccoli, cabbage, bok choy, brussels sprouts, add fiber, phytonutrients and antioxidants which decrease inflammation.
- The nitrates in these foods, dilate blood vessels and thereby lowering blood pressure.

3. Berries

- The nutrients in these berries help to improve memory and slow cognitive decline, repair DNA damage, provide vascular benefits, defend against cancer, improve insulin sensitivity.

4. Probiotics & Postbiotics

- Probiotics are fibers found in beans and lentils or intact grains like oats and barley. These fibers we ingest feed the good bacteria in our gut.
- Postbiotics enhancers are fermented foods (kimchi, sauerkraut, miso, tempeh, kombucha, plant-based kefir); they reduce inflammation, strengthen gut barrier, improve insulin sensitivity, support immune regulation.
- Both prevent color cancer.

5. Caloric Restriction

- A whole-food, plant-based diet is naturally low calorie and nutrient rich.
- Reducing your daily intake by as little as 300 calories between meals can put you on the road to lowering inflammation and slowing down metabolic pathways relating to aging. Aging adults should also consider restricting protein to 54 to 68 g. per day for a 150 lb. person. Animal protein spikes IGF far greater than plant protein.

6. **Protein Restriction** (especially animal protein)

- Reduce animal protein to less than 4 oz. a day or eliminate; Beans, lentils, tofu or tempeh for balanced plant protein; prioritize legumes over protein powders.
- Excess protein (especially animal protein) accelerates aging; animal protein spikes IGF-1, plant protein does not.

7. **Xenohormesis** (plant stress compounds)

- Colorful, bitter or pungent foods are richest in polyphenols, such as spices, herbs, teas, dark berries, coca and crucifers; when we eat them, they strengthen our resilience.
- Examples are grape skins and peanuts (resveratrol), apples and onions (quercetin), turmeric (curcumin), green tea (catechins) and broccoli sprouts (sulforaphane).

8. **NAD+**

- NAD is an important component found in every cell in the body. By middle age, the amount is reduced by as much as 50%. NAD can be boosted naturally with exercise, telework restriction, fasting and a plant-based diet.

Casey counseled those in attendance, “eat whole foods. Eat in response to hunger. Move your body. Prioritize deep sleep. It’s so important as we age. Diet is so most powerful. It’s never too late. You can see an improvement in as little as two weeks. There’s immense power in a healthy life.”

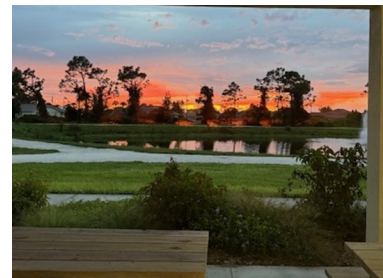

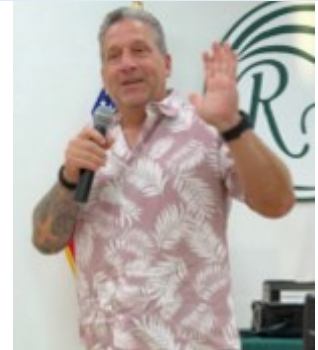

All About Alligators

Legal Status: The American alligator is classified by the US Fish and Wildlife Service as federally protected but allows state-approved management and control programs. In Florida Alligators can be legally taken only by individuals with proper permits.

Diet: Alligators are opportunistic feeders. Juvenile alligators eat primarily insects, amphibians, small fish, and other invertebrates. Adult alligators eat rough fish, snakes, turtles, small mammals, and birds.

Distribution: Alligators occur from Oklahoma and Texas to North Carolina and Florida. They prefer fresh water lakes and slow-moving rivers and their associated wetlands, but they also can be found in brackish water habitats.

Size: Female alligators rarely exceed 10 feet but males can grow up to 15 feet.

Reproduction: Alligators become sexually mature when they reach approximately 7 feet in length, which for a female is 10-15 years and a male 8-12 years. Courtship begins in April, and mating occurs in May or June. Females build a mound nest and deposit an average of 32 to 46 eggs in late June or early July. Incubation requires 63-68 days, and hatching occurs from mid-August through early September.

Survival: About 1/3 of alligator nests are destroyed by predators or flooding. The average clutch size is 38 and an estimated 24 live hatchlings will emerge. Only 10 alligator hatchlings will live to one year. Of these yearlings, 8 will become subadults (reach 4 feet in length). The number of subadults that reach maturity (6 feet in length) is approximately 5.

Three Tricky Sennas for your Butterfly Garden

Want to have a band of yellow butterflies swirling through your garden? The cooler weather brings the Cloudless Sulphur, the Sleepy Orange and even the Little Yellow butterflies if you have a trio of their host plants, the sennas, to feed their caterpillars.

The Bahama senna (*Senna Mexicana* var. (*chapmanii*) is a short-lived (3-5 years) native shrub that grows to 3-5 feet. Its feathery leaves are evergreen, and it does well in full sun or part shade. This is an excellent pollinator plant, and, in our area, it features yellow blooms all year. Part of the legume family, it produces seed pods, which turn brown. Harvest them to share with neighbors or let them grow where they fall. The Bahama senna attracts our solitary native bees and bumble bees as well as many butterflies.

A very similar native shrub is the Privet senna (*Senna Ligustrina*), also a host plant for those yellow butterflies. This long-lived perennial has a more pointed leaf than Bahama and can reach 8 feet high and 3-6 feet wide. Same buttery yellow flowers and seed pods. This is a “short-day” plant, requiring a longer period of dark to form its flowers, so it blooms from September to late spring. It will self-seed and tiny privets will appear in your yard.

What makes these two sennas tricky? A gland at the base of its leaves attracts ants that will feed on caterpillars, resulting in fewer butterflies. (source: Florida Wildflower Foundation, Florida Native Plant Society) Some caterpillars do escape the ants. In my yard, both sennas are grown for their appeal to nectar-loving butterflies and bees. To ensure the many yellow butterflies, I add one trickier senna.



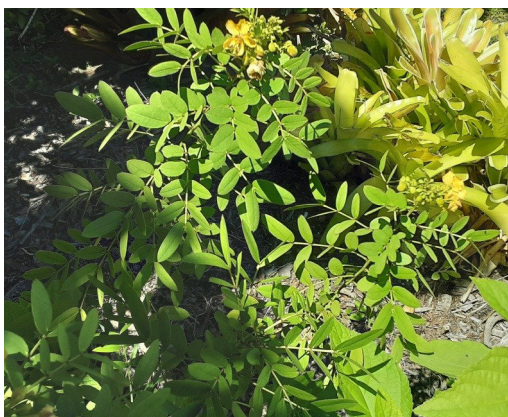

The third tricky senna is *Senna alata* or Candlestick plant which is native to Mexico and the West Indies. (Some of the non-native sennas are considered invasive, but the *alata* is easily managed by removing the large seed pods). This is a fast-growing tree, 8 feet tall and wide. It thrives in full sun and likes well drained loamy soil. The enormous leaves are rounded. The heavy branches can break in a storm so aggressive pruning in winter is recommended and results in more blooming. The flowers look like bright yellow candlesticks and are present all year.

This senna is the key to having MANY yellow butterflies. Having all three sennas in my garden, I have seen that the butterflies are most often on the *Senna alata* laying their eggs. How do they know about the ants on the Bahama and Privet? This time of year, there are many caterpillars feasting on the *alata*. The plants are so large, the leaf damage is not noticeable. If the caterpillars eat the blossoms, they are yellow; if they eat the leaves, they are green. The *Senna alata* is well known for its medicinal uses in treating ringworm,

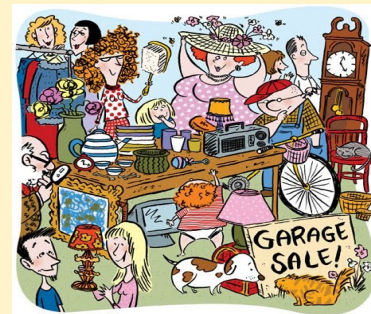

It is with a heavy heart that I am sharing a difficult experience that I hope will prevent others from falling victim to a similar crime. Over the past year, one of our residents was scammed out of over **several million dollars in cash and gold**. This wasn't a simple case of online fraud; it was a sophisticated, year-long con that preyed on their trust and fear. *Scammers go to great lengths to create an illusion of authority and legitimacy, which is exactly what happened.*

The scammers used what appeared to be legitimate FBI credentials, official-looking cars, delivery service (like Uber and Lyft) and secret code words to manipulate trust over time. *They are professional criminals. This isn't a simple case of a "scammer," but a complex criminal enterprise that requires a coordinated response.* They were so convincing that they made even our most experienced CCSO deputies question their own "scammer-detecting skills."

I'm sharing this as a critical warning. **Please be vigilant.** If a supposed government agent ever asks you for cash, gold, or gift cards, it is a scam. **Legitimate law enforcement agencies will never demand money** in this way. Don't be fooled by official-looking vehicles or credentials—these criminals are getting better and better at faking them. **Report any perceived scam to CCSO at 941-639-2101.**

My hope is that by sharing this story, we can save at least one other person from this of devastating loss. Don't let embarrassment or shame stop you from reporting this. By coming forward, you are providing crucial information that could help law enforcement stop them from targeting someone else.
