2025 RWA Election Results:

The Election Committee is pleased to announce that in the first year of its availability 1,970 RWA members chose to vote electronically. Adding the 447 mail-in ballots and the 4 in-person ballots to the e-votes, we arrive at a grand total of 2,421 members who voted this year. That represents an increase of 548 votes over the average for the past 4 years.

The committee offers its congratulations to our new Directors, Gwen Grace and Deb Orchard, and wants to thank everyone who voted this year.

The meeting was called to order by President Van Scyoc at 2:00 PM. The meeting was properly noticed, and a quorum was present.

The Pledge of Allegiance to the United States of America was said.

- Director Harvey moved the Board to approve the BOD Meeting Minutes for October 9, 2025, and the Motion was 2nd by Director Eldred. Motion Unanimously Approved.

MEMBERS INPUT (Agenda Items)

Rita Lopinski – 252 Rotonda West. A Member of the COC and is part of the Health and Wellness committee. Three-years COC started the Health and Wellness program. Last year we added a Thia Chi Class, and this year added a Pilates class. We have been offered to have a Yin Yoga class, and some members would like it added to the Health and Wellness group, which would be three times a month. Ms. Lopinski stated that women do not like to go to the gym because gyms are too far away, cost a lot of money and they are intimidated by men, and they feel the Community Center is a safe quite space. We want our Rotonda West members to be healthy and would like to see this program offered and think this would be a good additional program to add. Linda Paquette – 49 White Marsh, Ms. Paquette addressed the Board to support the Health and Wellness program of Yin Yoga that is currently up for the Board of Directors approval to add the third exercise class. The activities that the COC offer are good programs for the community and would like to see Yin Yoga class added to the program. If the Board is reluctant to pass the motion for the Yin Yoga class to be added permanently then (continued)

would they consider making it temporary and try it out for six months and reevaluate it. Terry Wagner – 204 Sportsman Rd. I did attend the Yin Yoga a couple of weeks ago and would like to add “my voice” in support of the program. Being a member of the Y, this program is not offered there. She stated that there are three pillars of health and wellness. When we added Pilates, we added strength and with the Tai Chi class we added balance and the third component is Yin Yoga so one can stay flexible. Please consider this program would be great for the community.

Donna Duffy – 56 Mark Twain. I was very excited that Tai Chi was offered for a health program for people who live here. It is important to keep your health, flexibility and strength. Please consider adding the program.

President Van Sycyoc questioned about the member’s comments. Notice that three have claimed they were intimidated by the men at the Y. He asked if the classes that are currently offered have men in the classes. Ms. Lopinski replied yes that there are about only one to two men that show up for the classes at the RWA Community Center. Mr. Eldred asked if the classes had any fees. Ms. Lopinski responded. There was no fee, but she needs to be certified, needs to be self-insured, she does have a tip jar out.

President’s Update: Andy Van Scyoc

President Van Scyoc stated he usually does not do a Presidents update but has one today and it is a “blockbuster”. We have the new Deed Restriction that were signed yesterday after 18 months. It took forever but it is done now. Also, the Association is going to offer free snow removal this year.

NEW BUSINESS & COMMUNICATIONS

MEMBERS INPUT (Non-Agenda Items)

RoseAnne Woodliff 152 Marker addressed the Board of Directors with her resignation from the Budget and Finance committee because she did not agree with the expenditures made for Gazebo Island.

Tom D'Abrosca- 156 Tournament Rd. approached the Board of Director stating that he was not in agreeance of how the process of the expenditures were decided on the upgrades to the Gazabo Island. Mr. D'Abrosca stated that he was resigning as the Chair of the Budget and Finance Committee.

Collen Koppenhaver – 101 Tournament Rd. a member of the Budget and Finance Committee for the Association stated that she puts her heart and time into the committee to make the organization better. She comments on the communications about the Gazebo Island expenditures, and she believed the by-laws were not followed appropriately. She asked the Board to take this as an opportunity to really take a look how it monitors, approves and handles expenditures for this organization. Recommended that the Board adopt an expenditure policy that will help management in the future to have a clear understanding of the processes to be followed and the approvals that are required and documentation of the processes and approvals.

President Van Scyoc asked the Board members if that had any comment or questions. Director Eldred stated that he had questions for the Manger Mr. Hedges about how the procedure works for obtaining bids for the planned projects and if the bidding process was followed according to the by-laws and state laws. Manager Hedges responded yes, remember the RWA Board went through quotes that were sent, also remember this was on the three-year plan years ago when the rip-rap repair was approved for the Island. The decision was (continued)



made from the bids received to approve the three-year plan. The process was followed it was approved back in 2024 the front entrance sign sidetracked the rip-rap project which was brought in-house. I contacted H & H Crane, and they had an opening for a couple of days, and he could do the job. Paul Bigness and the landscaper were also contacted to get the broken concrete and dead trees and roots and repair the riprap. This was a substantial saving by doing it in-house and ran everything through Paul for licensing and insurance which saved probably \$20,000.00 in riprap alone. So, with the additional funds they used to clear the damaged and bad concrete a decision had to be made, and don't regret it, it was a liability issue, damaged concrete, tree stumps, tree roots turned up and electrical wire sticking out of the ground. As Andy said, "first class community", and the Board is responsible for the common areas. We did go through the process with the Board of Directors, and it was approved. Director Eldred thanked Manager Hedges for his response.

Director Traverso addressed the Board of Directors in reference to Mr. D'Abrasca which he stated that RWA Board did not do the bidding right on the extension of the administrative building. He stated that he recalls that there was a long list of builders that were solicited. Only two bids came in Hampshire Homes and Synergy. Manager Hedges responded that the process had to be done a couple of times because of the time delayed of starting the project and bids had to be recalculated which did cover the proper procedures. Director Traverso stated that to set the record straight the RWA Board of Directors did their due diligence.

Director Besase stated that one of the previous President said that the HOA dues were raised twenty years ago from \$150.00 annually to \$160.00 which much of that was to do the erosion control at Gazebo Island, nothing was done for twenty years the concrete broke, the brush was overgrown it was a hazard. Several hurricanes had caused a lot of wear and tear on the Island and making repairs under the dollars amount that it was thought to cost, twenty years of neglect and now three months to make it right.

Maureen McDowell – 74 Pine Valley Lane State that she recently resigned from the Building and Grounds committee and does not agree with how the projects are being approved. Also thanked Mr. D'Abrasca for his oversight on the committee.

RESPONSE TO MEMBER'S INPUT

Director Kelly stated that he would like to thank Tom for his service on the Board and is sorry that he felt alienated by other member of the committee. Personality has alienated some other good board members. Items on the 3-year plan we approved items 2,4, 5,6 have only been approved for exploration they were not approved for full expenditure such as the \$150,000.00 roof these projects would have to come back to the Board for approval.

Director Harvey stated now that the sign is out front, it is beautiful and knows it will not be an illuminated sign with a revolving activity board on it, could we have a sign that says Board of Director Meeting today at 2:00 like the RWA bingo sign that can be placed out front on Thursday morning as a reminder. President Van Scyoc responded that it should be submitted to either the COC or B & G committee for review and submission to the Board of Directors.

Director Orchard stated that she applauded those who worked on the Budget & Finance Committee was sorry and sad that the only option was to resign, did not think this was intended with all the discussion going on. Thank you for your work and Ms. Orchard stated that she comes from an insurance background and worked with lawsuits that primarily happens when someone is injured. If you look at the Island it was a lawsuit waiting to happen and was shocked that RWA has not been sued over the disrepair that was out there. Even though a lot of you do not think the Island gets used, but it does and will be used more in the future.

Director Eldred stated it was unfortunate that the committee members resigned and it's too bad that it couldn't be worked out in a closed Board meeting.



President Van Scyoc thanked Deb Orchard and Jerry Eldred for their service on the Board, they are subject to the election and hopefully you make it back. All our four candidates are excellent, and with that he adjourned the meeting.

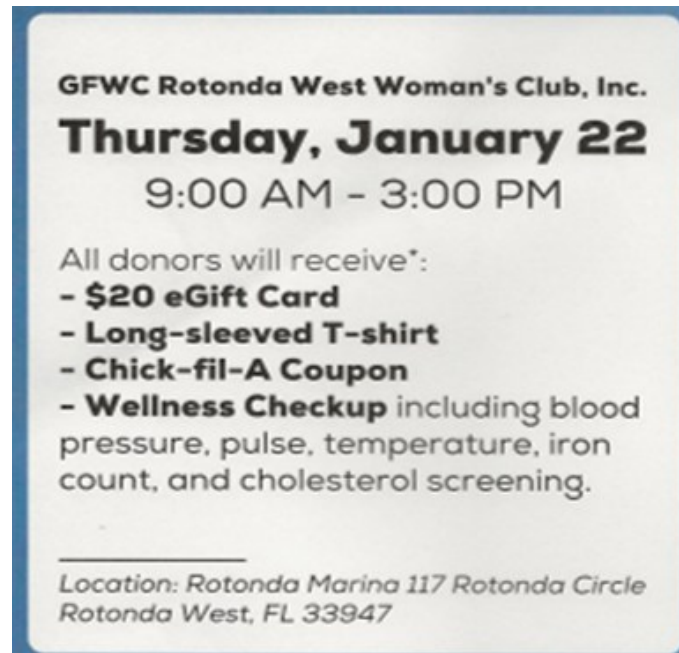

CHARLOTTE COUNTY NEWS ITEMS – JANUARY 2026

- PAVING - Rotonda West PAVING began on **MONDAY July 21, 2025**. \$17 million
- PAVING started in the PINE VALLEY section and move counter-clockwise (White Marsh & Broadmoor, etc.); each section takes about 4-6 weeks.
- MSBU PAVING – BY RWA SECTIONS: AJAX PAVING – VENICE OFFICE
- PROJECTED PAVING SCHEDULE–Subject to weather & equipment & manpower delays/ issues

- *ROTONDA BRIDGE #13 – ROTONDA BLVD SOUTH – UPDATE:
- I wrote all of the Charlotte County Commissioners as well as the County Administrator and the County Director of Public Works and I got the following reply from Mr. John Elias, the Charlotte County Director of Public Works:
 - Sam, I will try to answer your questions this way:
 - **Sam Question: Is there any NEW news related to the Rotonda bridge, namely, did Charlotte County ever receive the ACOE permit after the public comment period ended on October 24, 2025? UPDATE: As of December 22, 2025, still no ACOE permit.**
 - John Elias Answer: The public comment period has ended as you indicated. We expected to have the ACOE permit in hand already, but the government shut down has slightly delayed the process. We do expect it any day now.
 - **Sam Question: Have any further discussions been held with FEMA regarding the dollar amount to be provided to Charlotte County in light of the BCA court ruling in favor of Charlotte County in April of 2025? UPDATE: As of December 19, Charlotte County is now advising that there will be a SPECIAL MSBU meeting sometime in the first couple of weeks of January, 2026 specifically about the bridge?????**
 - John Elias Answer: This has been a real challenge that has only been exacerbated by the shutdown. Unfortunately, no new news to report here.

CHARLOTTE COUNTY NEWS ITEMS CONTINUED...

- **Sam Question: Has the bridge build bid specification been submitted to potential construction bidders?**
- John Elias Answer: Sam, in light of not having the permit and the ambiguity surrounding the funding the bid specs and plans have not been advertised yet. It is our intent to discuss this with the Board for them to weigh in on moving forward. The risk is that we potentially lose any funding from FEMA if we proceed without that being completely agreed upon. **(No new news!-SJB)**
- **Sam Question: Also, has the RW S&D MSBU unanimous motion to MILL & GRIND Rotonda Circle been forwarded to the Charlotte County Commissioners for approval of the change order to the paving contractor?**
- John Elias Answer: The request of the RW S&D was forwarded to the BCC in the form of a point paper as I committed to do in our town hall. There has not been a lot of direction from the Board, so Administration has asked me to prepare an item to present to the BCC at an upcoming meeting. We are finalizing those numbers, which are significant (\$527,000), and in doing so, had to then do an analysis to confirm if there was enough funding in the MSBU to cover it. That has been confirmed so this will be added to a future agenda. It should be noted that some of the residents have already taken action to prepare their driveways for not milling and if we switch courses there will be frustration.

GARDEN TIP FOR JANUARY

Panama rose
(*Rondeletia leucophylla*)

Why not start 2026 with an evergreen shrub that blooms in winter and brings fragrance to your garden? The Panama rose (*Rondeletia leucophylla*) has pink tubular flowers in clusters which appear off and on all year. It can grow to 10 feet tall, can be pruned to 3 feet and is 3-6 feet wide. Enrich the soil with compost or peat, and provide consistent moisture to obtain 1-2 feet of annual growth. Plant in full sun or part shade. It can take the heat.

Sometimes called Bush penta, this shrub is native in Central America. This plant attracts bees, butterflies and hummingbirds to its sweet nectar. There is a pleasing fragrance which grows stronger in the evening, making the Panama rose a perfect accent plant for a patio. Add three to a butterfly garden or use to form a hedge. Good companions are blue plumbago (*Plumbago auriculata*), the golden dew drop (*Duranta erecta*). Native lantana (*Lantana involucrata*), and dotted horsemint (*Monarda punctata*). Hard prune in spring to maintain size and remove dead branches. There is a Panama rose in the Butterfly Garden at Broadmoor Park.

Gardening for Wildlife is more important than ever as natural habitat vanishes in Florida. Learn how on **Wednesday, January 14, 2026 at 2 pm** with Sara Weber and the Nature Committee at the Community Center. Staying Vigilant After the Holidays:

The holiday season has come to an end, and we hope everyone enjoyed a wonderful time celebrating with family and friends. As we step into a new year, we are surrounded by countless opportunities to improve our lives through acts of kindness and positivity. Unfortunately, while many of us seek to do good, there are others who attempt to take advantage through deception and scams.

This time of year, is marked by the return of gifts and goodies received during the holidays. Many people are also eagerly awaiting confirmation that their bank or credit card companies have issued the proper credits for these returns. The process has become much more convenient; gone are the days when we had to wait for a paper statement to arrive in the mail. Now, you don't even need to log in to a computer – an instant text notification alerts you when credit has been made to your account.

However, this convenience also presents new risks. Instant alerts can create opportunities for scammers to strike when we least expect it, catching us off guard. As such, it's important to remain cautious. Here are five key signs to watch for that indicate a text message may be a scam.

Strange Phone Numbers

Slow it down. Is that the number your bank usually uses to send text messages? Legit text message updates come from an official 4-5 digit number used by your bank.

Urgent Warnings or Requests

Take a breath. Phishing texts try to create a sense of panic, such as threatening to suspend your account or urging you to log in to verify. Real bank texts won't.

Odd Grammar or Spelling Mistakes

Spot check! If you see misspelled words or odd grammar they are all clear signs of an impersonator. Real banks use spell check.

Requests for Personal Information

If a text message requests personal or sensitive information, such as account numbers, PINs, passwords, or social security numbers, you can assume it's a scam.

Suspicious Links

Banks rarely — if ever — send links via text. Don't click them. Instead, verify the message by visiting your bank's official website, or calling the number on the back of your card.

If you receive a suspicious text about your bank or credit card, **DO NOT** click any links, **DO NOT** reply to the message, and **DO NOT** call a number provided in the text. Instead, independently contact your financial institution using the phone number found on the back of your card or on their official website.

If you are looking to volunteer as a Patrol or be a Base Station, it just takes two hours a month; a small commitment to protecting our neighborhoods.
